Through Men's Space, Walking Football, exercise classes, and IT courses, Michael has rebuilt his life and navigating grief with the support of the Open Age community. Most meaningful has been the Men's Space Wellbeing Workshop, where he's openly discussed his mental health and grief journey. "It's very helpful when you socialise with people, because it takes your mind off other things that you might dwell on. It's good therapy," he says.

Such spaces have given him a safe space, support and a source of joy, and he passionately believes in spreading the word for others to also experience this: "I always enjoy coming to Open Age. We should keep advertising these groups, and make these conversations about mental health normal."

We know that you already understand the value of what we do—after all, you're a valued part of it! And that's exactly why we're asking for your help, which provides the community and connection that make Open Age so special. As the holiday season approaches, we're reminded how vital this connection is.
